Charles Borland, Jr., is elected a Representative in Congress, in Orange County, to supply the vacancy occasioned by the death of Selah Tuthill, by a majority of about 160 over John Duer.

Charles Borland, class of 1811, was born in town of Montgomery, Orange Co., N. Y. Prepared for college at Montgomery Academy. Was graduated with class of 1818. Was a member of the Society. Was quartermaster on staff of Major General Morgan Lewis (former Governor in War of 1812. Admitted to the Bar about 1816. Married Miss Isabella Hill of Montgomery. Their children were: Charles Borland who was graduated at Union College in class of 1842-died 1860. Isabella Hill Borland-married Rev. Lacy and removed to California. Gov. Borland was district attorney, member of the legislature, judge, member of Congress and surrogate. He spent his whole life in Montgomery and died miserably lamented in 1852.

## CHARLES BORLAND, Jr.

Of Montgomery, was a descendant of one of the early settlers (1738) of that town, and was for many years one of its most reputable citizens. He was surrogate in 1844, and special surrogate in 1855. In 1821, and again in 1836, he was elected Member of Assembly.

✓ **BORLAND, Charles, jr.,** a Representative from New York; born in Minisink, Orange County, N. Y., June 29, 1786; pursued preparatory studies; studied law, was admitted to the bar, and practiced; president board of trustees of Montgomery for ten years; member of the State assembly in 1820 and 1821; elected to the Seventeenth Congress to fill the vacancy caused by the death of Selah Tuthill, and served from November 8, 1821, to March 3, 1823; district attorney of Orange County 1835-1841; again a member of the State assembly in 1836; died in Wardsbridge, N. Y., February 23, 1852; interment in Riverside Cemetery, Montgomery, N. Y.
