At a meeting of the Rensselaer County Bar held at the Court House in the city of Troy, on the 30th day of May inst, the Hon. David Buel, jr., was appointed Chairman, and A. B. Olin, Secretary.

The Hon. D. L. Seymour, in a few impressive remarks, announced the death of the Hon. George Palmer, and concluded by offering the following resolutions:

Resolved, That the Bar of Rensselaer County have heard with deep regret of the decease of Hon. George Palmer, one of its oldest members,

Resolved, That the gentleness of manner, the kindness of heart, the noble firmmess and integrity of character, as well as the sound judgment and extensive legal acquirements of the deceased, rendered him an ornament to the Bar of which he was a member, and to the community of which he was a most valuable citizen.

Resolved, That we sympathize deeply with the bereaved family and relatives of the deceased, and that in token of our respect for his memory we will attend his funeral in a body, and will wear the customary badge of mourning for thirty days.
