Biographical / Historical

Louis C. Curth is the author of "The Forest Rangers: A History of the New York State Forest Ranger Force," published by the New York State Department of Environmental Conservation in 1987. Curth is a retired forest ranger who devoted his career to the Forest Preserve, working for the New York State Department of Environmental Conservation.

Content Description

The collection consists of research materials used in the writing of "The Forest Rangers: A History of the New York State Forest Ranger Force" (1987) and includes manuscripts, reports, correspondence, photographs, and other records detailing forest ranger history as well as glimpses into Curth's career.

Curth continued to collect and compile materials relating to ranger history after the publication of the book into retirement.

Manuscript materials contain original typewritten versions of each chapter as well as edited and revised book drafts.

Research files consist of various newsclippings, articles, correspondence, and other assembled files by subject that were originally compiled in preparation for the book.

Printed materials consist of published and printed summaries, annual reports, various DEC publications, manuals, and maps relating to specific environmental issues and forest ranger policies.

Photographs and negatives depict vehicles, fire control, formal portraits, events, training, construction, and various structures. The bulk of the collection consists of black and white prints.

Objects and ephemera include Smokey the Bear memorabilia, certificates, signage, trail registers, a corporate seal, and other small items.

Audio and visual materials include VHS tapes, a 16mm film reel, and audio cassettes which document ranger history, daily duties, and special events.

It was finally published in 1987 by the New York State Department of Environmental Conservation.

Scope and Contents

The series consists of formally printed reports, guides, handbooks, manuals, maps, plans, and publications used for training, general information, and carrying out of daily ranger operations. Materials are arranged chronologically by date of publication to give the researcher a view of how ranger policies evolved throughout the 20th and 21st Centuries. The bulk of the publications were printed by the State of New York Conservation Department Division of Lands and Forests, Bureau of Forest Fire Control and later the New York State Department of Environmental Conservation.

Scope and Contents

The series consists of objects and ephemera relating to forest ranger history, outreach, special events, and operations. The materials are arranged by format. Items pertaining to Charles T. Barnes, Forest Ranger and Game Protector are the oldest of the materials. The bulk of the series consists of Smokey the Bear memorabilia used in outreach events in the 1970s and 1980s which include stickers, booklets, pins, pencils, and other promotional items. Also included are temporary signs and trail registers from the Fred Lyon Observer Tower on St. Regis Mountain.
