1804 HARMANUS PEEK.

At a meeting of the Judges abd Bar of the County of Schenectady, on the 27th day of September, 1838, the Hon. John Titus was called to the chair, and Platt Potter was appointed Secretary.

The Hon. S. W. Jones stated the object of the meeting to be for the purpose of paying the proper tribute of respect to the Hon. Harmanus Peek, whose

death had been announced this morning.

Whereupon a committee, consisting of the Hon. S.W. Jones, Thomas Palmer, and John Sanders, esqs., were appointed to draw resolutions for that purpose, who reported as follows:

Resolved: That this meeting express its deep regret at the decease of the Hon. Hatmanus Peek, a member of the bar, and at the time of his decease, one of the judges of the County; that his example as an honest, amiable and unassuming private citizen; a respected member of the legal profession; a vigilant and uncorrupt magistrate; an upright judge; a faithful member of the legislature, both of this State and of the United States is recommended with pride to the imitation of others who may be placed in situations similar to those of our late associate. That in testimony of our respect for his memory, we will attend his funeral in a body and wear the usual hadge of mourning for thirty days.

Resolved: That we condole with his family at their irreparable loss, and that the Chairman and Secretary transmit a copy of these resolutions to his respected

widow.

Resolved: That the foregoing resolutions be published with the proceedings of this meeting.
