Biographical / Historical

Per O. Moberg (1920-2011) was a conservationist, licensed guide and officer of the Adirondack Mountain Club and Sierra Club. Born July 14, 1920 in Brooklyn, New York, he was a son of Per J. and Lilly (Russell) Moberg. He was raised in Sweden and served in the Swedish Navy during the Second World War. Per graduated from the Stockholm Institute of Technology with degrees in mechanical and electrical engineering. He returned to the United States in 1947 and worked for Sperry Gyroscope Company, eventually retiring from New York State Department of Environmental Conservation. His entire life was devoted to the outdoors and the environment. He loved fishing, hiking and canoeing. As a licensed guide, he took many groups into the Adirondacks. Per was a member of the Easton Town Planning Board where he resided until his death in 2011.

Scope and Contents

Administrative records, working files, memoranda, reports, impact statements, correspondence, writings, photographs, newspaper clippings and other materials documenting Moberg's professional work. Materials tend to focus around specific campaigns and issues affecting the Forest Preserve. Navigability law and public navigation rights on the Moose River center on a lawsuit between the Sierra Club and the Adirondack League Club. Other projects involved abandoned railways, collecting background information on specific wilderness areas and general administration of the Park. Land acquisition documents show various easements, purchases and transfers of private land to the Forest Preserve including the Tahawus tract and Champion Lands. Correspondence is mostly of a professional nature and includes letters and emails regarding land acquisition, advisory committee work and amendments to unit management plans.

Unit management plan drafts and summaries for lands administered by the New York State Department of Environmental Conservation in the Adirondack Park. Also included are earlier plans as written by the Division of Lands and Forests written in the 1970s that were later superseded.

Scope and Contents

The bulk of the series consists of publications received by Per Moberg during his professional work. They include reports, summaries, statistics and technical papers on Adirondack history, Forest Preserve management, policy, soil health, sustainability and ground water. Historical materials include original state land surveys transmitted to the the legislature by Verplanck Colvin in the 1890s.

Maps types include topographic, planimetric, and historical land partitions used by Moberg for unit management planning. Topographic maps contain marginalia.
