Biographical Note: Thomas Cobb's earned a Bachelors degree in civil engineering from RPI and a Ph.D. from the School of Environmental and Resource Management, SUNY College of Environmental Science and Forestry. He served in the Peace Corps in Honduras and Peru from 1967-1970 working on rural community development and earthquake reconstruction. He was Director of the Ecological Forestry Program for the National Parks and Conservation Association; a lecturer for the Department of Natural Resources at Cornell; Associate Environmental Analyst at the Environmental Management Bureau; Manager of Saratoga Spa State Park, OPRHP; Park and Recreation Specialist on the NYS Commission on the Adirondacks in the 21st Century, Natural Resources Specialist and NYS Trails Coordinator, Planning and Research Bureau, NYS OPRHP, and Manager Minnewaska State Park Preserve. He was Trustee and President of the Association for the Protection of the Adirondacks, Founding Director of the New York Parks and Conservation Association, Chairman of the Trail Use Policy Committee of the NYS Erie Canal Recreationway Commission, Secretary of the New York State Trails Council, Chairman of the NYS Forest Preserve Centennial Committee on the "Forever Wild Covenant," Instructor of "The Future of the Adirondack Park at Skidmore College, and Chairman of the Adirondack Research Center and Library at Union College.
