Died: Yesterday morning, Jacob T.
B. Van Vechten, esq., Judge Advocate
General of this State, in the 40th
year of his age.-
Albany Argus, January 21, 1841.

At a meeting of the members of the
Bar of the city of Albany, held.

Son of Hon. Abraham and Catherine (Schuyler) Van Vechten, was born at Albany, N. Y., May 10, 1801, and died there on June 20, 1841.

He married Caroline C. Roorbach, daughter of Captain Arthur Roorbach, and she died December 6, 1852.

At a meeting of the Bar of the city of Albany, held at the Supreme Court Room in the Capitol, on the afternoon of Thursday, 21st inst., to make arrangements to attend the funeral of Jacob T.B. Van Vechten deceased, the following resolutions were offered by James Edwards, Esq., and adopted:

Resolved: That we deeply deplore the decease of our brother, Jacob T.B. Van Vechten and sympathize with his afflicted family, in their irreparable loss; and as a testimony of our regard for his high character as a lawyer and a fellow citizen, we will attend his funeral, and wear the usual badge of mourning for thirty days.

Resolved: That the members of the Bar will meet at the Temperance House on Sunday next, half an hour before the time appointed for the funeral and attend from thence in a body.

Resolved: That these resolutions be published in the city papers, and that a copy be communicated to the family of the deceased.
